- PICKUP/DROP OFF OUTSIDE OPENING HOURS: only on request € 20
- When your flight is delayed and you are waiting for the shuttle, you can send an SMS message to +34 607 476441 to inform the vehicle fleet provider that you have arrived. The vehicle fleet provider is keeping an eye on the flights.
- DEPOSIT: Credit card (with pin code) in main driver's name is mandatory. Amex/Dinner's card, EC-, Debit-, Prepaid Cards, Visa Electron and non-embossed Credit Cards are not accepted. The deposit is a full tank.
- DRIVERS LICENSES: Each driver must have been in possession of valid drivers license for at least 1 year.
- FUEL POLICY: Please return the car with the same amount of fuel as at the start of the rental. If the vehicle is not returned the same as received, the rental company can charge you for the missing fuel + service charges.
- MINIMUM/MAXIMUM AGE: minimum age 21 years for cat. YB, AB, BB; 23 years for all other categories. Maximum age is 74 years.
- YOUNG DRIVER SURCHARGE: 19-20 years old possible for cat. YB for € 14 per day. 19-20 years old possible for € 14 per day for cat. AB, BB, but only as additional driver, the main driver needs to be 21 years or older. 21-22 years old possible with charges, but only as additional driver, the main driver needs to be 23 years or older, the charges are: € 16 per driver per day for cat. DB, QV, DR, DC, DRE; € 18 per driver per day for cat. FV, FW; € 20 per driver per day for cat. VB
- SUPPLEMENT DRIVERS WHO ARE 75 YEARS OF AGE OR OVER: € 7 per day for cat. YB, BB; € 8 per day for cat. DB, DR, DRE; € 9 per day for cat. FV, FC; € 12 per day for cat. WB
- FINES: in case of fines, the rental company will charge you € 47 administration charges per fine.

ONE WAY RENTALS / CROSS BORDER

- ONE WAY RENTALS: on request only possible from Malaga Airport to Fuengirola and vice versa. Charges: 1-2 days € 20; 3 days and longer free of charge
- CROSS BORDER: It is allowed to cross the border to Portugal and Gibraltar. The vehicle fleet provider however doesn't recommend to take the car into Gibraltar to save valuable time. There are strict border controls and long waiting times from both sides. The advice is to park the car near the border and go on foot, the distances are very small.
